#### Spraying of D.D.T. in Sagar Municipality.

Q.-210. Sri S. GOPALA GOWDA (Sagar-Hosanagar):-

Will the Government be pleased to state :---

whether representations, have been received from Sagar Municipality for spray of D.D.T. in the Town and if so, what have they done in the matter?

A.--Srf T. CHANNIAH (Minister for Public Health and Local Self-Government).--

A representation from the Municipal Council, Sagar, was received during July 1951 and the President was intimated that the Local Bodies should pay 50 per cent of the cost of spraying work. An estimate for Rs. 11,181-11-0 for one round of D.D.T. spraying on the basis of the work done by the World Health Organisation was got up and forwarded to the President, Municipal Council on 29th September 1951. The Municipal Council have so far tot agreed by a resolution to meet 50 for cent of the cost of Rs. 11,181-11-0.

### Enlarging Forest Area.

Q.-229. Sri V. M. MASCARENHAS St. John's Hill).---

Will the Government be pleased to tate :---

(a) the area covered by forests in he State and its percentage to the total rea;

(b) whether it is their policy to icrease this area;

(c) if so, the steps that are being aken to implement this policy?

A.-Sri T. CHANNIAH (Minister for 'ublic Health and Local Self-Governnent).-

(a) 4,704 64 square miles. The otal area is just about 15 per cent of he land area of the State.

(b) and (c) Though the percentage f Forests to land area in the State is ir below, the accepted international tandard of 25 per cent, the scope of nlarging the area is very limited as imost all the wooded lands in Malnad aving out enough for the ryots to sercise their rights under Malnad 'aiyats' Special Privileges Rules have lready been reserved. There is also tout organised opposition in maidan reas by the raivats for bringing any inds under reservation. On the other and, the number of applications for isafforesting even the existing areas or cultivation is on the increase of late, nd in view of the "Grow More Food" ampaign and the food scarcity, such pplications are being carefully scruti-ised and action is being taken to eserve as much of the wooded area djoining the notified State Forests as ossible. To supplement the natural rests, artificial plantations of fuel pecies are being raised on a large scale ound about Bangalore under" Post Var Development Scheme" and fuel nd teak plantations are also being vised yearly in all important State prests to intensify the forest growth.

### Reservation of Posts for Backward Class Citizens.

Q.-283. Sri M. MADIAH (Nanjangud - Scheduled Castes).--

Will the Government be pleased to state:--

(a) whether they have made any provision for the reservation of appointments or posts in favour of any backward class of citizens which in their opinion is not adequately represented in the services under the State (Mysore) as declared in the Article 16 ( $_{\circ}$ ) of the Indian Constitution;

(b) the names of the backward communities which come under the above backward classes of citizens;

(c) if the answer to (a) is in the affirmative, the names of the communities which in their opinion are not adequately represented;

(d) if the answer to (a) is in the negative, the reasons as to why such provision has not yet been made?

A.—Srl Kadidal MANJAPPA (Minister for Revenue and Public Works).—

(a) The existing procedure of reserving 75 per cent of the direct recruitment vacancies for the backward classes is being continued and no separate orders have been passed under Article 16(4).

(d) The Government of India have not yet constituted a backward classes commission and the subject of changing the rules regarding the reservation for backward classes is under the consideration of Government.
